- -Unmodified Opinion -Clean report and materially correct in regard to accounting principles
- -General fund balance of \$4,736,220 which included an increase of \$958,906
- -Capitol projects fund balance of \$1,855,247 which included an increase of \$1,491,358
- -Food service net balance of \$220,495 which included an increase of \$46,921
- -\$18,756,000 of the USDA construction loan (approximately half of the loan) had been spent

The board had no questions and the report was received as information.

 - -January 16 State wide ELA testing begins

- -Legislative discussions regarding an amendment to use funds to support private schools (Bill 556).
