Mrs. Goodman moved that the request be approved. Mrs. Thompson seconded the motion which passed unanimously.

 - Sale of remaining school furniture and equipment scheduled for May 13-14.



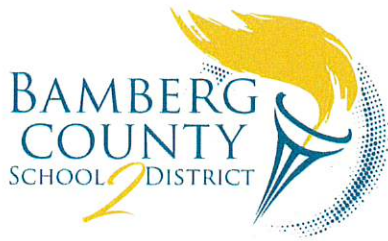
